Minister's Report from the Rev. Dr. Sarah B. Linn

2024 was a challenging but satisfying year for me.

I continued to serve as the Moderator for the Rocky Mountain Conference of the UCC (comprised of the 70-some UCC ministries across Colorado, Wyoming, and Utah). The demands of this "repair" work eased somewhat as we developed and implemented a transition plan that should leave the conference in a stronger position, in terms of finances and faithfulness. As I've said many times, there is *no way* I could have taken on that role without confidence in our CCC leaders. *Many* thanks to our Officers, Deacons, Trustees, and ministry team leaders! I'll complete my term as RMC Moderator at the 2025 General Synod in July. *Phew!*

After 7 years at the Red Church in 2024, I was afforded a 3-month sabbatical. I stepped away from day-to-day ministry for half that time – taking 6 weeks to start a writing project that I'll continue to develop through 2025 (and likely beyond!). I so appreciate all of you – especially our Deacons – allowing me to take a brief season to focus on a different expression of ministry than what I've done before. I hope it will become something useful down the road.

I'm excited about what lies ahead for our influence as a faith community in Creede and each of the places we represent. We continue to gather stakeholders in Mineral County to address concerns related to housing, addiction, and behavioral health. Let me know if you are interested in using your gifts in any of these areas.

As for the church building itself, we finally secured a bid toward the end of 2024 for long-needed exterior painting. And, in record time, we raised more than the \$30,000 we needed! So, we're scheduling that work for this summer. Next, we'll focus on replacing our furnaces. Once we have figures in hand, we'll do what we can to raise needed funds and start that work in 2025, as well.

Meanwhile, our Trustees continue to keep the wheels on our operating budget wagon. We can expect to hear financial updates from them throughout the year. Helping the whole congregation know what's going on will help us stay on solid financial footing and avoid falling into a pattern of significant deficit spending in the years ahead.

All this to say, I'm so thankful for the commitment of our leaders! The reports in this packet represent the wisdom, faithfulness, generosity, and welcome of God's Spirit in and through this congregation throughout 2024. Well done, everyone! Here's to an amazing 2025!

TRUSTEES REPORT

The primary function of the Board of Trustees is financial oversight. It is the responsibility of the members to create a budget to present to the congregation with oversight throughout the year. Unlike many organizations, the church has chosen to operate with a deficit budget, meaning that our budgeted expenses exceed our budgeted revenues. We operate on faith to provide for our community through missions and outreach like Helping Hands, Mission Trips, Projects, and other projects.

The annual budget for 2024 planned for a deficit of about \$22,000. We ended the year with expenses exceeding income by about \$30,000. A large portion of this overage was due to ongoing maintenance and repair of the parsonage. While the church dipped into savings to meet our operating and maintenance expenses, we are still very financially sound and have adopted a new method to budget and raise funds for capital expenses.

Starting in 2025, capital and maintenance expenses (like painting the church) have been removed from the operating budget and will be funded by special pledge drives. Additionally, we are establishing a team to help evaluate the church's buildings and create a multi-year plan to address deferred maintenance on problem areas and proactively plan for future maintenance.

Each summer, we hold a stewardship campaign, inviting pledges toward the following year's operating budget. This helps our Trustees anticipate overall giving and determine a realistic budget. Our 2025 pledges are over \$20k higher than what was pledged for 2024. With the additional pledges expected this year, our 2025 budget includes a \$23k deficit. To track this deficit and additional gifts given against it, we have added a new line to the budget titled "God Money." The Trustees will report to the congregation on a quarterly basis to track our financial situation.

Overall, the church is overwhelmingly blessed by our financial position. The Trustees will continue to carefully watch over us, maintaining our position for the future.

Once again in 2024, we saw several new folks join the church, which is always exciting. We held "Coffee with the Deacons" sessions to share stories, discuss faith, and answer questions. Throughout the year, we tried to let members, friends, and neighbors know that the Red Church is here for them to help with practical needs and/or prayer requests. This included sending greeting cards to many of our congregants near and far during Advent.

Deacons set up and serve Communion each month and help with First Sunday Potluck in the off-season, which continues to be fun, delicious, and full of fellowship with one another. We also assisted with Tech Dinners for the Creede Theatre in 2024 and look forward to similar opportunities in 2025.

CHRISTIAN LIFE EDUCATION

Current: Christian Life Education at CCC

- 1. We currently have five volunteers that teach Sunday School at CCC. As always, we would welcome additional volunteers to assist with children's enrichment.
- 2. During our annual Christian Life Education meeting (April 4th, 2024) we discussed 1) the previous 2023-2024 year, 2) supplies, 3), safe church policy, 4) goals/projects for the upcoming year, and 5) other business. Based on conversation that took place during this meeting, we decided to:
 - a. Extend our Celebrate Wonder Curriculum by utilizing one lesson over a 2-week time period (wk 1: younger child lessons, wk 2: older child lessons)
 - b. Seek to find ways to engage our congregants in the 12-18 year old range that no longer attend Sunday School
 - c. Create binders (coloring tools, activity pages, etc.) for children that would like to stay in the main church service, or for weeks when we may not have a Sunday School instructor
 - d. Incorporate a "children's time" into the adult church service on alternate weeks in order to offset the shortage of Sunday School volunteers
 - e. Create and maintain a curriculum binder in the CCC office space so that teachers can easily access the curriculum, including activities to be copied for Sunday School
- 3. During our last annual meeting I had mentioned the possibility of needing two Sunday School classes as we had a significant number of children in the 2-6 age range, as well as the 7-10 age range. Sadly, we've had several wonderful CCC families with young children move away from Creede over the previous year.
- 4. Michelle Meals had the idea of hosting a "Parents Night Out" event where CCC would provide babysitting so that parents could have an evening out. Jenni Harbour and Sarah Linn continued forward with the concept, and our first "Parent's Night Out" will occur on Friday, January 31st.

Possible Action Items: 2025-2026

- 1. We have yet to create the activity binders that children have the option of using during the adult church service, but I believe this would be helpful and a goal for the upcoming year.
- 2. I have been the Christian Life Education Chair for the previous 3 years, and my term will end in 2026. Are there others that may be interested in taking on this role in the future?
- 3. It would be wonderful if we could give the Sunday School room a refresher/update
- 4. Outreach/Collaboration with the Baptist Church in regards to Wednesday Night Youth Group
- 5. Evaluate curriculum during Christian Life Education Meeting in the spring

MISSION/OUTREACH AND HELPING HANDS

Special thanks to returning team members Jamie McLeroy, Margaret Phillips, Carol Pierce, Linda Walker, Linda and Mike Dubbs, and Jana Bean Wilson for their excellent work this year!

In 2025 we are wishing a very fond and grateful Bon Voyage to Jana Bean Wilson, who is relocating to Thailand for at least 2 years. We are so thankful to her commitment to our church and community! 2025 will see Mike Dubbs taking on even greater responsibility, co-chairing the Mission & Outreach team along with Bethany, who remains the administrator for Helping Hands.

2024 HELPING HANDS ASSISTANCE

Again this year, we were able to provide financial assistance to all community members who made requests! We gave over \$6000 to cover a wide range of needs including medical and dental bills, utilities, disaster funds, rent and winter heating costs. Helping Hands ended 2024 with a balance of \$3,677.47 (not including deposits totalling \$801 from the Christmas Eve Candlelight Service).

2024 MISSION/OUTREACH CHARITABLE DONATIONS

Thanks to God's faithfulness and the unfailing generosity of our community we were able to send thousands of dollars in contributions to ministry partners including Creede Early Learning Center, La Puente, Creede Public School District (mental health services), Creede Repertory Theatre (youth program scholarships), Creede Dental Works, Zuni Missionary School in New Mexico and Backbay Mission. We also contributed to the UCC's "Our Church's Wider Mission" fund and two special UCC offerings ("Neighbors in Need" and "Strengthening the Church").

Preventative Dental Care Initiative

Mission & Outreach has been partnering with Creede Dental Works to provide preventative care for local children and Veterans. Our dental hygienist provides preventative care including cleanings, x-rays, fluoride and other services discounted by 50%. 18 families have benefited from this program since it began in Dec 2023.

Local Care Packages

We continue a care package program for local residents. This allows us to purchase OTC medications and supplements, soup, tea, juice, tissues and little happies/cheer 'em ups at Kentucky Belle to deliver to neighbors in need due to illness, disaster and/or bereavement.

Socksgiving! 2024

During 2024's Socksgiving!, we collected and delivered 751 brand new pairs of socks to support La Puente's efforts to serve those experiencing homelessness in the San Luis Valley.

La Puente Christmas Tree

Mission & Outreach offered the congregation the opportunity to serve the clients of La Puente, through donating toys and gifts via a gift tree.

Kentucky Belle Holiday Gift Cards

Mission & Outreach donated \$1000 worth of K-belle gift cards for community members in need as the holidays approached. Silver Thread Public Health assisted in disseminating these gift cards locally.

Backbay Mission Trip to Biloxi (Feb 2025)

Due to traveling schedules, weather and boulders through roofs, we did not have a team to send this year. Again this year, we were able to make a \$1000 donation to this deserving mission.

As arms that reach out into the community to show the love of God, we are excited by the progress we've made in 2024. We continue to welcome all church members to join the Mission & Outreach Team or to participate in any of our projects!
